#### 3. Budget 2022-23 Update & Budget 2023-24 Planning

Neil Gibson (NG) and Joanne McBurney (JMcB) provided an update on the 2022-23 budget. Attention is now turning to focus on next year's budget exercise. JMcB highlighted the need for DoF Public Spending Directorate (PSD) to gather relevant data to allow them to present recommendations/options to Minister(s) on Budget 2023-24. Given the funding shortfall next year, rather than the usual approach for Resource DEL of plus/minus change to a baseline position the proposal is to gather data on departmental spending which will allow a more zero-based approach. PSD propose commissioning an exercise before Christmas with departmental responses due before the end of January. [Action: Joanne McBurney]
